Economic Significance


• Provides a market for Indian commodities and is a destination for Indian investment




## Average Share of Bhutan's Top 10 Export items to India(2004-2016)

#### **Bhutan's Trade with India**

- The total export value in 2020 including electricity was Nu.43.51 billion and excluding electricity was Nu.27.52 billion.
- Remains steadfast to maintain continued bilateral trade talks to build upon the existing trade relations
- Explore new avenues for expanding trade and commerce between the two countries.
- In 2020, overall trade with India was recorded at Nu. 94.89 billion (including electricity), which accounted for 82% of Bhutan's total external trade and without including electricity was recorded at Nu. 67.18 billion, which accounted for 77% of Bhutan's total trade. The overall import from India accounted for 87% of the total import value with or without taking into account trade in electricity. Exports to India accounts for 90% of total exports including electricity and 77% without electricity.

#### **Indian Assistance for Bhutan FYP**

India has committed assistance of

- ₹4500 crore for the implementation of development projects
- ₹400 crore for the transitional trade support facility during Bhutan's 12th Five Year Plan (2018 2023).

#### **Indian Assistance for Bhutan**



- To mitigate the effects of COVID 19 pandemic, Government of India has provided early releases of Nu./Rs. 5.01 billion from the committed development assistance since March 2020.
- Helped Bhutan achieve its economic targets, and indeed, the country is scheduled to "graduate" from the category of Least Developed Country to a developing economy in 2023.
- Committed a financial support of Nu./Rs. 45 billion comprising Nu./Rs. 28 billion of Project Tied Assistance, Nu./ Rs. 8.5 billion of assistance towards High Impact Community Development Projects and Nu./Rs. 8.5 billion of Program Grant assistance.



# **Hydro Electric Power**

India has agreed to assist Bhutan in the development of minimum of 10,000 MW of hydropower and import of surplus electricity from same by year 2020.

#### **Culture and P2P connect**

- Cultural bonding between India and Bhutan is rooted in the ancient practice of Yoga. Yoga has gained great popularity among the Bhutanese.
- Government of India provides number of scholarships to Bhutanese students.
- Regular cultural exchanges take place and enhance people to people exchange in cultural field.





# **Border Management**

- Secretary-level mechanism on border management and security related matters.
- Border District Coordination Meeting (BDCM) Mechanism between the bordering States and the Royal Government of Bhutan (RGoB) to facilitate coordination on border management and other related matters.







## Future scope of trade relations between India and Bhutan

- Agreement on Trade, Commerce and Transit between the Royal Government of Bhutan and the Government of the Republic of India is valid till 2026.
- Signed 10 Memorandum of Understandings in the field of space research, aviation, IT, power and education.
- Establishing a railway link between Mujnai (West Bengal) and Nyoenpaling (Bhutan)
- India's cooperation in Bhutan's five-year plans will continue
- Committed to facilitate Bhutan's development through the use of space technology
- India will enhance the communication, public broadcasting and disaster management coverage in Bhutan
- An additional trade route under Jaigaon Land Customs Station (LCS)



## Future scope of trade relations between India and Bhutan

- The reconstruction works are aimed to rebuild and consolidate the existing Dzong structure while maintaining the heritage value associated with the historical site.
- It will help create better conditions for the district administrative officers and the Rabdey monks residing in the Dzong as well as the visitors to this prominent heritage site of Bhutan.
- The reconstruction of the Dzong is being funded by India through its Project Tied Assistance of Nu./Rs. 1 billion spread over the 11th and 12th Five Year Plans of Bhutan. The project will be completed in July 2022.



#### **Tourism in Bhutan**



- Tourism is very important source of Bhutan's revenue (65% of total tourists are from India)
- Bhutan is an example of sustainable tourism
- Bhutan will now impose a "sustainable development fee" (SDF) on Indian Tourists, making visits more expensive.



#### Under Neighbourhood First Policy of India

- Strengthen cross-border relations and foster regional connectivity
- India has launched BHIM UPI
- Focuses on peaceful relations and collaborative synergetic co-development

## **Agriculture in Bhutan**

- Agriculture contributes only 10 percent to GDP but accounts for 54 percent of employment. about 66 percent of poor household heads work in agriculture
- The agriculture sector continues to absorb the majority of the workforce by employing 51.1% of the working population despite accounting for only 16.2% of GDP.
- There continues to be a disparity in income with the average income earned by a worker in the industry and the service sectors is Nu 354 and Nu 604 per hour, , while it is only Nu 67 per hour in the agriculture sector.
- The contribution of the industry and service sector is 41.8% and 42% (2017 est.)
- While employing 23.3% and 34.9% of the workforce. The unemployment rate is calculated at 2.7 % (2019).



## Foreign policy

#### Resolution on foreign policy

- The five cornerstones of the foreign policy as "samman" (dignity), "samvad" (dialogue), "samriddhi" (shared prosperity), "suraksha" (regional and global security) and "sanskriti evam sabhayata" (cultural and civilisational links).
- "These five themes have become the Panchamrit, the new pillars of our foreign policy,"
