Needo-empathy for Middle Class

—in Swarnim Bharat –







Prof. M.M. Goel

he purpose of this article is to justify empathy for the Indian middle class which is contributing to the economy more than any other class and is suffering from ills including inflation more than others. This is needed to stop middle-class people to be converted into poor in times to come if not taken care of with empathy. After the celebration of Azadi Ka Amrit Mahotsav, we must think of Bharat to be Swarnim towards 2047 after achieving sustainable development goals (SDGs) in 2030. In certain ways, the Indian economy has evolved since independence but there is always a scope to be better than the best. A thousand of rationalities cannot give us that sensitivity (needoempathy) needed towards the middle class in India to become Swarnim Bharat.

Empathy is greater than sympathy as lip service we do for the people at large including the middle class. Empathy dissolves otherness and justifies oneness as summation (yog) in spiritual mathematics (1+1=1) authenticated in Gita which is relevant for all Indians including the middle class.

According to the pan-India study "The Rise of India's Middle Class" based on a survey by People Research on India's Consumer Economy (PRICE) in 63 cities with a population of more than 10 lakh in seven categories of cities with middle class as households with an annual

income of Rs 5 Lakh-30 Lakh (\$6700-\$40000). The study reveals that the share of the middle class in the total population rose from 14 per cent in 2004-05 to 31 per cent in 2021-22. One in every three Indians is "middle class" in India with income between Rs 5 lakh and Rs 30 lakh per annum. This number of expected to double by 2047, placing two out of every three Indians in the category of the middle class. It has been revealed that 27 per cent of the middle class live in India's top 63 million-plus -population cities. In metros and boom -towns, the middle class makes up more than half of the households. In niche cities, the middle class accounts for 40 per cent of the households. The study reveals that aspirers with an annual household income of Rs 1.25 lakh to Rs 5 lakh in 2020-21 prices is a crucial segment for the take-off of basic consumer durable goods and form 45 per cent of the households in the million-plus cities. The nine metros are the largest markets in terms of household disposable income and total consumption and serve consumption centres. The 16 boomtowns are emerging as large markets with young populations and the fastest growth in disposal income. There are 38 niche cities with a population of 1 million-2.5 million displaying a very high level of spending per household. In the metros, nearly 55 per cent of households are middle class. According to NITI Aayog, India is the second largest urban system in the world and is expected to contribute 73 per cent of the total population increase by 2036 in India (MoHFW, 2019).

For ensuring ease of living for the middle class in Swarnim Bharat, there is a case for the availability of quality goods and services at reasonable prices with minimal inflation justified as needo-inflation for an



economy. Needoflation (need of inflation) is a level of inflation within tolerable limits (between 3 per cent to 4 per cent) which could lead to positive growth implications. Infect, inflation depends on the basket of goods consumed by the people and varies from person to person with gender, age and income. Inflation in India is a well-known location-specific economic problem with social implications for various categories of consumers most notably the middle class.

It is pertinent to mention that when the wholesale price index (WPI) based inflation rate used to be lower than the consumer price index (CPI) based inflation rate, we were able to find out that the retail inflation was higher because of poor governance and control of the government on retailers and the gap between the WPI and CPI-based inflation was to be reduced so that the redressal of grievances of consumers can take place. Now the story has changed and the gap is there between WPI and CPI-based inflation but WPI based inflation rate is higher than the CPI-based inflation rate. It has to be understood, analysed, and interpreted by the researchers. In our considered opinion the higher WPI-based inflation rate reveals that it is "cost-push inflation" due to the increase in the price of crude oil, petrol, diesel etc. Whereas in earlier times higher CPI-based inflation rate was due to "Demand-Pull Inflation". The paradox needs to be resolved. The lower rate of CPI-based inflation (core Inflation) is due to the basket of goods where there is no weightage for petroleum and energy products which have more weightage in WPI. There is a case for the alternative methodology of measuring inflation. We have observed that inflation in absolute term has an impact more on the middle class in comparison to the rich (never bother of MRP) and the poor does not consume most of the commodities used for measuring inflation in India. To cope up with the inflationary crisis, we need to identify the factors under control and beyond control with a proper measure of

inflation. We have to be motivated to succeed in doing a thing which calls for change in behavioural patterns as consumers. We have to be aware, alert, and awake with wisdom and rationality (vivek) for the challenges faced by middle-class Indians and remain enthusiastic to work without worries. We have to become street SMART (simple, moral, action-oriented, responsive and transparent) Indians as consumers to face socio-economic challenges as middle class. There is a need for policy implication-oriented research and not only t - value significance at a 95 per cent level of significance with many disconnections between India's growth and the middle class. Our research should provide policy implications which make the nation capable of facing the challenges in all times to come. Monitoring and evaluating the performance of the Indian economy is a Needo-consumption as righteous continuous process. consumption with mindfulness is required to be understood and analysed as an eclectic approach (with no to attitude of eating to live or live to eat). To justify Needoflation (need of inflation) a level of inflation within tolerable limits could lead to positive growth implications required to be studied by the researchers. It is worth quoting J.M. Keynes 'It is better to be roughly right than to be precisely wrong' in the collection of data on inflation and its impact on the middle class. We require some standards of transparency and a code of conduct for stakeholders as middle class with the potential to contribute and call for needo-empathy in policy formulation for Swarnim Bharat towards 2047.

HOW TO STOP FLOODING OF CHINESE IMPORTS?

n the first nine months of the year 2022, imports from China have reached \$89.66 billion. In the corresponding period in 2021, Chinese imports were only \$68.46 billion. Imports from China were \$ 97.5 billion in the whole year 2021 and if this pace continues, Chinese imports may surpass \$120 billion in 2022. Increasing imports from China are becoming a serious concern because it increases the trade deficit and therefore, foreign exchange liability of the country. If we see, in the first nine months of this year, the total exports to China from India were only \$13.97 billion, which means a trade deficit of \$ 75.69 billion. It is believed that by the end of this year, the trade deficit with China could reach \$ 100 billion, which will be a record.

Significantly, in view of increasing imports from China and due to this increasing dependence of India on China, the government adopted various measures under the Atmanirbhar Bharat scheme. At first, 14 industries were identified, which included electronics, medical equipment, Active Pharmaceuticals Ingredients (APIs), telecom products, food products, ACs, LEDs, high efficiency solar PV modules, automobiles and auto accessories, textile products, special steel, drones, etc. These were industries that have either faced closure or are at the verge of closure, after lagging in competition in the face of increasing imports from China. Dumping by China

at predatory prices, export subsidies by the Chinese government and the insensitive policy of the then government and continuous reduction of import duties helped Chinese to capture Indian markets.

Why are imports from China increasing?

Today, when the Government of India is trying to provide new life to closed or on the verge of closure industries through PLI scheme, technical support and various other measures under Aatmanirbhar Bharat (self-reliant India) programme, then what is the reason that despite that rise in Chinese imports is continuing unabated. It is notable, that the imports of Chinese electronic and electrical machinery and its components, active pharmaceutical ingredients, that is APIs and other intermediates are increasing rapidly. The government's argument is that since imports from China consist mostly of intermediate goods, it is a good sign and indicates increased manufacturing in the country. It is also argued that value addition on the import of Chinese intermediate goods in the country also creates employment in the country. It is also said that since the intermediate goods come from China at cheaper prices, the cost of production also comes down, making Indian industry more competitive. On the basis of this argument, pro-globalization economists do not mind increasing import, and rather advocate further reduction in import duties.

Significantly, despite the strong opposition to Chinese goods in the country, the Chinese imports are increasing continuously, because a large part of the imports coming from China are not of finished consumer goods, but of capital and intermediate goods including machinery and chemicals. The big question is whether India lacks the capability to make these intermediate goods? Perhaps it's not correct. It is beyond comprehension that a country which is a super power in many fields including space, software, automobile, missiles, cannot manufacture intermediate goods of zero technology. It has to be



understood that capacity building in India has been obstructed by China by dumping cheap goods and adopting many other unfair trade practices; and this conspiracy is not ending. It is said that business is a war and has to be fought as such.

Active Pharmaceutical Ingredients(APIs) is a vivid example in this regard. 20 years back India used to provide for 90 percent of its API requirements, while dumping from China and other countries destroyed our API industry and today 90 percent of APIs requirements are met from imports. Such a huge dependence of our pharmaceutical industry is proving to be a big threat not only to the economy, but also to health security. Not only PLIs, the government has to adopt several other supplementary measures as well, so that in future Chinese imports do not destroy the upcoming Indian industry again.

The question here is not only about direct imports from China. A large amount of Chinese imports into the country are also coming through various ASEAN countries. Significantly, India has a free trade agreement with ASEAN countries, under which most of imports from ASEAN countries come at zero import duty. When Indian authorities started stopping Chinese imports imposing country of origin condition, Chinese companies started setting up their factories in ASEAN countries only, due to which now Chinese imports cannot be stopped by tagging them as Chinese. This calls for revisitingIndia-ASEAN Free Trade Agreement (FTA).

Apart from this, many foreign automobile and other companies working in India, are also getting spare parts from abroad. When India increased the import duty on mobile phones, many foreign companies started their manufacturing in India. But still large quantities of components are still being imported from other countries including China. India has sufficient potential in the field of raw materials and intermediates for textiles and apparel, but unfortunately, we see a huge import from abroad, resulting into huge under-utilised capacity in the

sector.For instance, textiles imports from China were higher by 46.2 percent in 2021-22, as compared to 2020-21, which is causing huge under-utilisation of capacity in the textile sector.

It is noteworthy that in the last one year, most of the imports from China, be it chemicals, plastic goods, textiles, machinery, have all increased much more than before. On the one hand, the government is trying to revive those industries which were either destroyed or greatly affected due to not being able to compete with China, by spending hugely under the PLI scheme. Although the results of PLI scheme and other measures are yet to come, but in addition to these measures some additional efforts would be required. We can learn from USA in this regard. In the year 2018, the then US President Donald Trump raised import tariffs in several parts; and in total, tariffs on \$ 250 billion imports from China were increased to 25 percent. The obvious result was huge reduction in Chinese imports. In 2017 the total imports of these goods were \$ 231.7 billion, which declined to only \$ 147.5 billion in 2021.

On the similar lines, if India also curbs the imports coming from China by increasing the import duty, it will have two benefits. One, the country's trade deficit will reduce and the burden on foreign exchange can also be reduced. Secondly, promotion of these industries will help manufacturing GDP and employment to increase. It is important to mention here that while even today our import duty is around 10 percent on an average, India can increase import duty significantly, even up to 40 percent as per bound rates committed under WTO rules.

2014 AND 2022 RUSSIAN INVASION OF UKRAINE: SUMMAR

he research paper shows that in midwinter, Russia shut off gas supplies to Ukraine in January 2009, and this left the Ukrainians to freeze in their homes. Russia seized Crimea from Ukraine in 2014 and has supported pro-Russian secessionists in eastern Ukraine. Moreover, Russia accuses both the US and NATO of surrounding the country and aims to subvert it. Although, Russians managed to reign in most parts of Ukraine. This conflict has resulted in increased tensions between the Western people and the Russians and also raised the number of refugees.

Most international institutions and governments, and webpages globally as undoubtedly respectable and decent beings of the twenty-first century without either a second thought oppose the Russian president's assertions of attacking Ukraine to only "feel secure, develop and exist". The truth is that each nation that was initially a member of the USSR existed in Eastern Europe near Russia having similar affiliation interests with the west and desire to join the Northern Atlantic Treaty Org (NATO) having some injustice Russian belligerence associates of comparable size and authority like the United States bought into disarray with its conflict with Russia. Meanwhile, Ukrainian is on the Russian authorities' target for a long time, with Putin's intimidation to annihilate the global peace of nations like Sweden, if they enter the British Forces. All main power and administrative, and military superiority, however, was contractually guaranteed in its political entity, Russia, being the largest and greatest nation till now, also hosting the Union's capital city of Moscow.

A current example of Russia's aggression for the sake of "national security" is the Impending attack on Ukraine, which has rocked the whole nation, race, and territory to all its bases. Others say that Russia's invasion of Ukraine has directly affected its nationwide security by reducing Ukraine's role as a buffer state to both Russia and NATO and raising the risk of Western sanctions and



isolation. It is worth highlighting that the Russian invasion of Ukraine has caused significant human misery, which cannot be justified only based on "national security and national interest." It's basically down to each person to determine whether they feel Russia's argument for attacking Ukrainians is justified.

Some observers believe that Russia's acts in Ukraine involve more in establishing its dominance in the region and impact more than they are in safeguarding its boundaries. Therefore, whereas expanding its strength and influence is a crucial motivation for Russia in Ukraine, it is far from the only one. Additional motivations for Russia's efforts in Ukraine may include a desire to weaken NATO and the European Union, or to sow unrest in an area that is traditionally hostile to Russia. NATO is still a political union comprised of nations opposed to Russia; thus, by disrupting Ukraine, Russia could be attempting to destabilize NATO and damage its legitimacy. Furthermore, Russia regards the European Union as a possible adversary, thus by undermining Ukraine, Russia may be attempting to harm the EU and erode its power. The United Nations General Assembly, on the other hand, unanimously condemned the attack, and most nations don't acknowledge Russia's Crimea annexation. Furthermore, Russia and Ukraine have an ancient legacy, and several Russians regard Ukraine as a natural consequence of their nation.

In conclusion, Russia has a significant native population in Ukraine, and Russia could have wanted to safeguard these individuals in the case of sectarian strife or bloodshed. The Russian attack on Crimea in 2014 saw Russian conventional forces engaging and conquering Crimea, an independent region in Ukraine. This time, Russia invaded Ukraine directly, resulting in tremendous conflict and strife. For instance, if Ukraine is invaded by Russia, other nations may also be entangled, and the situation may expand to a broader confrontation.

Climate Change and the Indian Economy: Current status and future implications

he accumulation of greenhouse gas emissions (GHG) has already resulted in observable and measurable shifts in the climate around the planet. Recently, the COP27 (Conference of parties) in Sharm El Sheikh, Egypt brought attention once more to the growing impact that emissions of greenhouse gases are having not just on the environment but also on all of mankind. Given these circumstances, it is of the utmost importance to have a solid understanding of the numerous effects that the acceleration of climate change will have on the economy and society in general.

The term "climate change" refers to "gradual alterations in temperatures and patterns of rainfall over extended periods of time". As a result of climate change and rising average world temperatures, mountain glaciers are dissolving, sea levels are climbing, and oceans are growing increasingly hotter. Droughts lasting longer and being more severe pose a danger to agriculture, wildlife, and freshwater supplies. The richness of life on our planet is in jeopardy as a result of the changing climate, which threatens everything from polar bears in the Arctic to sea turtles off the coast of Africa.

The Fourth National Climate Assessment, which was published in 2018, issued a dire warning that the

world's economy might be severely harmed by the effects of climate change if we do not reduce our emissions of greenhouse gases and begin to adapt. Temperatures that are higher than normal, an increase in ocean levels, and harsh climate will cause severe loss to property and essential infrastructure, have a significant effect on human health and productivity, and have a detrimental influence on industries such as manufacturing, agriculture, forestry, fishing, and tourism. The production of electricity will become less dependable, which will result in a rise in the demand for energy, and water supplies will be stretched. The disruption in commerce and supply lines that would result from the damage done to other nations across the world will also have an effect on the economy of India.

Reports on the potential severe effects that climate change could have on economies have been released by a number of research from throughout the world. In a recent study, researchers looked at how climate change could impact 22 distinct sectors of the economy under two distinct sets of circumstances: if average global temperatures rose 2.8 degrees Celsius above their pre-industrial levels by the year 2100, and if they rose 4.5 degrees Celsius above those levels. In any event, according to the findings of yet another research, the United States and India stands to incur significant economic losses as a result of climate change.

Up to the year 1990, the majority of the historical blame for climate change was placed on the shoulders of the more industrialized nations. Only the United States and Europe were responsible for



about 75 percent of the world's total CO2 emissions between the years 1850 and 1990. The question of how much of the responsibility for lowering present and future emissions should rest on the shoulders of rich nations as opposed to developing countries has been at the forefront of discussions over this topic of historic responsibility.

In the Recent discussions at COP27 EU has proposed their plan to levy "cross-border carbon tax." Under this framework, the EU intends to extend its climate policies with respect to imports for the very first time in an effort to attain climate neutrality. In its most basic form, the carbon border tax entails the imposition of an import tariff on a product that was created in a nation that has more relaxed environmental regulations than the country that is purchasing the goods. The Carbon adjusted Mechanism may severely impact iron, steel, cement, fertilizer and aluminum industries. This idea, on the other hand, is opposed by the nations that make up the BASIC group, which are India, China, Brazil, and South Africa. In order to lessen their impact on the environment, a number of developed countries have begun to levy steep taxes on industries with a high carbon footprint within their borders. Carbon leakage is the process by which businesses have the potential to circumvent this requirement simply by relocating their production to a nation that has regulatory standards that are laxer. On the other side, these sorts of activities impede the economic growth of developing countries, which may lead to an increase in the amount of poverty and hunger that exists in these nations.

Agriculture is India's primary means of subsistence, and more than sixty percent of rural households in the country rely on it to provide for their families. Agriculture and associated industries are responsible for 15.4% of India's Gross Domestic Product (GDP). Because of the risks posed by the climate, the agricultural industry is the one that is most

susceptible to the effects of climate change. Under the National Innovations in Climate Resilient Agriculture programme, research on the effects of climate change on India's agricultural sector was conducted (NICRA). In the scenarios of 2050 and 2080, it is projected that India's yields of rain-fed rice will decrease by a small amount (less than 2.5%), while the yields of irrigated rice will increase by 7% in 2050 and 10% in 2080. This situation is dangerous to the food security.

To conclude, in the realm of science and technology, one of the most pressing growing problems is climate change, both in terms of its causes and its effects. India, which is located in a tropical region, is experiencing the effects of climate change in the form of droughts, floods, cyclones, heat waves, hailstorms, and coastal salinity, all of which pose challenges to the country's efforts to achieve sustainable development. About 70 percent of the population in India is either directly or indirectly involved in agriculture and its sub-sectors, and a significant contribution to the achievement of the Sustainable Development Goals (SDGs) is anticipated from this industry. The rise in average global temperature, which is being caused by the production of vast quantities of greenhouse gases from a variety of sources, is the root cause of climate change and its associated effects. Temperatures that are abnormally high and the unpredictable occurrences that accompany them interfere with the daily operations of every living thing on the earth, either by causing extensive harm or loss. In this context, it is of the utmost importance to educate every person about the negative effects, both in the short term and the long term, as well as the methods in which they may protect themselves on an individual basis.




