She further said that the recently launched National Green Hydrogen Mission with an outlay of ₹19,700 crore will facilitate the transition of the economy to low carbon intensity and reduce dependence on fossil fuel imports.



K's Tokamak Energy has said that it has built the world-first set of newgeneration high-temperature superconducting (HTS) magnets to be assembled and tested in fusion power plant-relevant scenarios. Tokamak's new Demo4 facility will consist of 44 individual magnetic coils. Demo4 will have a magnetic field strength of over 18 Tesla, nearly a million times stronger than the Earth's magnetic field.






isit of External Affairs Minister to Fiji and Australia (February 15-18, 2023)



### **Union Budget 2023-24: Perceptions of a Needonomist**

close perusal of the proposals in the union budget 2023-24 of the size of Rs 4503097 crore by Finance Minister (FM) Ms Nirmala Sitaraman in her 5th speech of 58 pages spoken in 86 minutes reveals that the measures taken in the budget proposals were necessary but not sufficient for the economy of Sawrnim Bharat towards 2047. It should have given energy and enthusiasm to all the stakeholders in tune with the seven priorities as the 'Saptarishi' guiding us through the Amrit Kaal-Inclusive Development, Reaching the Last Mile, Infrastructure and Investment Unleashing the Potential, Green Growth, Youth Power, Financial Sector Immunity booster for the health sector. It is pertinent to mention that the task of pleasing all the stakeholders is difficult if not impossible in a democratic nation. There are resource constraints faced by the Indian Government.To become blessed, fortunate and lucky in 2047 to be Swarnim Bharat, we have started preparations for opportunities with our strengths and challenges. We understand our weaknesses too in terms of the population with unemployment, under-employment and poverty. Three features including smart economics, confident politics and credible fiscal numbers as claimed in an editorial of TOI are to be understood, analysed and interpreted by the stakeholders in right perspectives. It has to be noted that budget is more than a statement of expenditure and receipts for the next year 2023-24 as an insight of the philosophy of the government of the day on economic issues with outlook on long run (25 years) with target of Swarnim Bharat in 2047. Long run may be a misleading guide to current economic affairs as J.M. Keynes once said "In long-run we may all be dead". Sadly opposition is politically incapable to raise issues on supply side vision (ignoring demand side) to revamp Indian economy. To sustain the momentum of infrastructural development, we must lay the foundations for job-led growth in the shock proof economy but needed PPP model in letter and spirit. To be targeted for Swarnim Bharat in 2047 is well received and convey the confidence of the politicians in power with no opposition to Needonomics School of Thought with commitment. The measures for protection from uncertainties in future calls for needo-education of the stakeholders including consumers, producers, distributors, traders and politicians in power and opposition. The observed shift from welfare spending to investment is welcome step but we have to ensure proper monitoring based on the canons of public expenditure by Dr. B.R. Ambedkar in terms of faithfulness, wisdom and economy in execution. The little decline in subsidy allocations is a welcome step in the right direction. The intent of taking firm steps for achieving a fiscal deficit (FD) of Rs 1786816 crore (5.9 per cent) in 2023-24 to reduce to 4.5 per cent of GDP by 2026 are missing and lost in over enthusiasm and challenges. 'More Returns' from 'Less Expenditure' with a cost-effective approach needed to reap from today's investment for tomorrow. There was little manoeuvring space for total expenditure as 2/3rd of 100 is spent on debt servicing, defence, transfer to States, subsidies and pensions. By adding salary cost it becomes 3/4th of



the budget. The total budget size of Rs 4503097 crore in 2023-24 conveys an exercise to allocate relatively small 25 percent of that. Borrowings were to be better monitored. Capital expenditure enhancement conveys better quality expenditure for infrastructure. FRBM Act calls for moral-suavasive fiscal path. We were expecting big macro picture beyond the numbers. (interest payments, pensions, salaries, defense, grants to 28 States and 9 UTs). To ensure implementation of NEP, the allocation for education is Rs 112898 lakh crore including Rs 44,094.62 crore for higher education. It should be noted that the Academic Bank Credit (ABC) of NEP 2020 can enhance students' confidence index (SCI) and may reduce educational inequalities and justifies Capex in education for needo-education for needoemployability and needo-entrepreneurship. The permission for world-class foreign universities is not in good taste but a confession that we are weak. The excessive stress on digitalization may have implications but calls for cyber laws to take care of the cybercrimes. FM must explain the use of education cess collected from the income taxpayers for effective implementation of NEP with many challenges including financing the States.It is believed that sustainable growth in private consumption is needed for becoming \$ 5 trillion Indian economy but the risks on high inflation may not be in good taste based on wrong methodology of measurement done every month. There is a need for introspection on income and wealth inequalities as the world inequality report mentioned that inequalities in India are more than in many countries in the world. To increase GDP we must have demand for goods and services by the people who have higher MPC (marginal propensity to consume). There is a strong case of redistribution of income and wealth. It is pertinent to mention that inequalities cause tension, discontent, corruption and crime. It leads to a decline in sense of belonging. We should make honest efforts for justice, equality and unity in India

which is possible only by redistribution of income and wealth through a concrete plan of action including tax reforms. The middle class is expected to be 47 percent by 2030 as consumers have a definite role to play and their disposable income stands enhanced by flexible tax slabs and reduction in surcharge rate are welcome step. We have to create faith in the fundamentals of the Indian economy by adopting the user-pay principle so that the hopes of the stakeholders are not belied. Indian economy can be made consumer-friendly by adopting the NAW (Need, Affordability and Worth) approach of marketing with a focus on the need-based priorities in choices of all kinds. Atmanirbharta is a necessary and sufficient condition for sustainable development of an economy and its people by keeping a check on greed which is the villain for all of us. For the vision of Swarnim Bharat, we must be committed as consumers, producers, distributors, traders and the entire government machinery as street SMART (simple, moral, action-oriented, responsive and transparent) Indian. We have to understand and adopt the principle of needonomics as a Swadeshi idea of Bharat in totality which includes needoconsumption, needo-saving, needo-production, needo-investment, needo-distribution, altruism, needo-trade for glocalization (think globally and act locally), needo-environment and above all needoinsurance for needo-happiness Let us be ready for the next reforms in the Knowledge economy of Bharat. We must understand the Needonomics School of Thought for Swarnim Bharat as knowledge economy to become world leader as Vishav Guru. We must remember that the goodness of the budget lies its implementation and effective use of the allocation which calls for faithfulness, wisdom of the professionals and economy in execution- the canons of public expenditure given by Dr B.R Ambedkar.

he valley of Kashmir is home to snowladen mountains and attracts thousands of tourists annually with its exquisite handicrafts. The Kashmiri Carpets and Shawls are famous worldwide for their handwoven beauty. The real heroes behind the beautiful handicrafts of the valley are its gifted artisans who have been doing this for ages and are responsible for making the valley's art famous and for carrying the thousand years old legacy forward for the younger generations to learn from.

One of these unspoken heroes is Mr. Yaqoob Bafanda. Born and brought up in a humble family in the valley, Mr. Bafanda describes how he believes destiny is nothing but how much effort a man puts into his work to achieve his goals.

"With the right number of hours put into your work, good intentions in heart, and god's blessings one can achieve anything they wish to."

When you scroll through his Instagram you would find various pictures of beautifully woven Kashmiri shawls that would make you stay on his Instagram page a little longer than you had intended to. Beautiful art crafts made out of paper mache and cotton suits of Ari embroidery are to look for. Bafanda tells that every piece of work requires precision and practice to maintain the quality of work.

He told that his family has been involved in the business of handmade carpets and shawls even before he was born. He describes how his father used to wake up at the brink of dawn and work till late at night. His father has been his source of inspiration all his life. Watching him work relentlessly to provide the family with everything inspired Mr. Yaqoob to work honestly and never give up despite how challenging the circumstances to get.

In 2020 when the world suddenly came to a halt due to the deadly coronavirus many businesses were uprooted and artists had to sleep on an empty stomach. At times when people were only buying the necessities, it was a far fetch dream for them to buy expensive carpets and shawls. Artisans, Businessmen, and laborers around the world suffered the wrath of COVID-19 through stocked-up warehouses and zero to null sales. The valley too suffered the rage of the pandemic



and made several businesses shut down which are still finding it hard to surface back in the market.

Yaqoob's business was also affected by the pandemic and he had to spend several months in his home uncertain of what the future may behold for him. This is when his well-wisher Ms. Praveen Shalini Dhawan approached him to venture into the business of dry fruits. Yaqoob who was already going through a lot was uncertain and concerned about starting a new business at times when it was hard for even ageold businesses to survive. But when his friend showed faith in him, he surrendered himself to god and leaped into the business of dry fruits. The business did well enough to get him through the lockdown.

Most people hire digital marketing experts to expand their business on social media but Yaqoob did it all by himself without anyone's help. He started posting pictures of his work on social media and for several months received no response. He nearly gave up and one day received a message from a foreign client who was interested in buying one of his carpets. By word of mouth, he expanded his business abroad and now ships orders to his customers in the UK, US, and other countries around the world.

The last few years have been rocky for Yaqoob but his determination and hard work helped him sail through it all. Artists like him possess talent beyond measure and give you a hundred reasons to shop local. There are several people around you like Yaqoob who wake up every day and work till they achieve their target even when they are halted by unimaginable forces. Your one purchase from a local artist can benefit many lives.

# Decoding Union Budget 2023-2024 Saptarishi (Seven Priorities) paving the way for India's Amrit kaal

India, which was long regarded as one of the developing countries in the world, has recently established itself as a leading country with strong economic stability on the international stage. The economic conditions of the nation proved to be steady in spite of risks like as the conflict between Russia and Ukraine, disruptions caused by the COVID-19 epidemic, prolonged high levels of inflation, etc. The G-20 is now being led by India which offered an opportunity for the country to represent the emerging nations on global stage. As a result, the budget of the nation has captured the attention of governments from all over the world. Under these specific conditions, 'The Union Budget 2023, which was presented by the Minister of Finance Nirmala Sitharaman, has paved the way for the future development of the country to be more sustainable via the "Saptarishi" vision.

- 1. Inclusive development: According to USAID, Inclusive development is the notion that every individual, regardless of identity, contributes to the transformation of their society. Following are the proposed initiatives the Government of India towards achieving inclusive development in various sectors.
- Through "Agriculture accelerator fund" innovative start-ups in rural areas will be encouraged. Atma Nirbhar Bharat Horticulture Clean Plant program to boost production of high value horticulture crops with an outlay of 2200 crores.

- 20 lakh crore rupees agriculture credit targeted at Animal Husbandry, dairy and fishing sectors.
- "Sree Anna" initiative for making India global hub for Millets
- A mission to eliminate sickle cell anemia by 2047
- National digital library for children and adolescents
- 2. Unleashing the Potential: India has enormous potential in every industry. As a consequence, the finance minister notes that Unleashing India's Potential is an additional Budget priority. The government has announced the establishment of three specialist AI centers academic institutions to deliver AI-based solutions for Agriculture, Health, and Sustainable Cities. I addition, an integrated online training platform will be established, "iGOT Karmayogi", to give lakhs of government workers with chances for continual learning and to support a people-centric approach.
- Less stringent contract execution scheme for MSMEs "Vivad se Vishwas I" and Vivad se Vishwas II is scheme will be launched to facilitate the faster settlement of contractual disputes of Government and Government Undertakings.
- For the effective administration of Justice Government announced the phase 3 of "E courts"
- To promote safe document storing and sharing inside the business environment, Entity Digilocker will be established.
- · Research and Development Grant announced for Lab grown diamonds (LGD) sector to reduce the import dependency. Establishment of 100 labs for 5G
- 3. Green Growth: The Union Budget 2023 expands upon India's resolve to lead global efforts to combat climate change, protect biodiversity, and



promote sustainable development. PM-PRANAM scheme is announced to encourage states and union territories to adopt alternative fertilisers and a balanced use of chemical fertilisers. In addition, "500 New waste to wealth plants" will be established Under GOBARdhan scheme to promote circular economy. MISHTI (Mangrove Initiative for Shoreline Habitats and Tangible Incomes) Scheme for Mangrove plantation is also announced.

- 4. Infrastructure: The creation of infrastructure enables the movement of labour and capital within/out of the economy. It also results in the general expansion of cities and towns. The Union budget 2023 placed high importance to the infrastructure development and the following are the provisions mentioned in the budget related to infrastructure.
- The finance minister has proposed an increase in capital expenditures for infrastructure development of Rs 10 lakh crore (3.3% of GDP).
- An interest-free fifty-year loan to state governments has been extended for one more year, along with a Rs 2.4 billion investment for railways and Rs 75,000 billion for 100 transport infrastructure projects, including Rs 15,000 billion from private sources.
- · Creation of Urban infrastructure in Tier 2 and Tier 3 cities through Urban Infrastructure Development Fund (UIDF).
- 5. Youth Power: India began the demographic dividend era in 2010, when around 51% of the population was of working age, and will continue to reap the benefits until 2056. To reap the advantages of the nation's demographic dividend, the nation's youth must possess enough skills. To accomplish this, the union budget for 2023 includes the following provisions.
- · Within the next three years, the government will launch the Pradhan Mantri Kaushal Vikas Yojana 4.0 to skill lakhs of youngsters.
- · In order to prepare youngsters for worldwide chances, thirty Skill India International Centres would be established in various states.
- · In addition, 47 million youngsters will get a stipend over the course of three years. A Direct Benefit Transfer will also be implemented as part of

the pan-India National Apprenticeship Promotion Scheme.

- 6. Financial Sector: Financial sector is the backbone of the Indian economy, and the following key provisions are included in the financial sector.
- · A redesigned loan guarantee plan for micro, small, and medium enterprises with a budget of Rs 9,000 crore was proposed and inaugurated on April 1.
- Domestic tourism would be encouraged via the initiative of "Dekho Apna Desh".
- The "National Financial Information Registry" will be established in order to facilitate the efficient flow of credit and promote financial stability.
- 7. Last mile connectivity: Provision of last-mile connectivity is one of the government's primary objectives. The government has established the Ministries of AYUSH, Fisheries, Animal Husbandry, Dairy, Skill Development, Jalshakti, and Cooperation in order to offer a tighter emphasis on the 'Reaching the last mile' mission.
- · In addition, the budget for 2023 recommended the formation of a PMPVTG development mission.
- The Union government planned to hire 38,800 teachers and other personnel for 740 Eklavya Model residential schools during the following three years.
- · Government will also provide financial assistance of Rs.5300 crore to the sustainable micro irrigation projects in drought prone areas of Karnataka.
- · Bharat (Shri) initiative will be launched to digitalize ancient inscriptions.

In addition, the union budget 2023-24 included modifications to the new income tax system to make it more appealing to taxpayers. In a nutshell, In Budget 2023-24, India's development imperatives are cautiously balanced within the constraints of budgetary restraint. Concerning the rural poor is the Rs 60000 crore budget reduction to the Mahatma Gandhi Rural Employment Guarantee (MGNREGA) plan, which is 32% less than the revised projection for the current fiscal year. However, the budget cut to the Mahatma Gandhi Rural Employment scheme (MGNREGA) (Rs. 60000 crore) which is 32 per cent less than the current financial year's revised estimate is a cause of concern for the rural poor.









# **OBITUARIES**

ormer Chief Justice of India A M Ahmadi died on Thursday after a briefillness. He was 90. He is survived by his children Huzefa Ahmadi and Tasneem Ahmadi, both leading lawyers.Born on March 25, 1932, in Surat, Justice Ahmadi was the 26th Chief Justice of India. In 1964, Ahmadi was appointed a civil and sessions judge in Ahmedabad and went on to become the state's law secretary. In 1976, he was appointed a judge of the Gujarat High Court and was elevated to the Supreme Court in 1988. He was the CJI from October 1994 to March 1997. In his nine-year tenure in the Supreme Court, Justice Ahmadi was part of seminal verdicts that changed the course of polity. A critic of the Collegium system of appointing judges, Justice Ahmadi, who was in line to be CJI then, had written a dissenting opinion in the 1993 landmark ninejudge bench ruling that established the Collegium system of appointing judges. Justice Ahmadi had said that the majority view by Justice J S Verma "follows a path leading to a destination unknown to the Constitution".



ormer Gujarat governor and veteran Bharatiya Janata Party (BJP) leader Om Prakash Kohli has passed away at the age of 87. He was the 19th governor of Gujarat from 2014 to 2019. While presiding as Gujarat governor, he also served as the governor of Madya Pradesh and Goa. A former Rajya Sabha member and ex-president of BJP in Delhi, he was also a leading academician.



bi Suresh, a 41-year-old actor and television host from Malayalam, passed dead. The actor's first theatre roles were as a comic and dancer. When she starred in Mazhavil Manorama's Meant for Each Other, she quickly became well-known. She also performed a variety of comedic roles on programmes like Cinemala. Subi has appeared in a number of Malayalam television programmes as well as the films Grihanathan, Thaksara Lahala, and Elsamma Enna Aankut.




