





The board of Aditya Birla Capital Ltd (ABCL), which is into lending, asset management and insurance, on Thursday approved a preferential issuance of Rs 1,250 crore to its promoter and promoter group entity, according to a statement on Thursday. he government's rice procurement has reached 52.06 million tonnes so far in the ongoing 2022-23 marketing season, benefitting 1.12 crore farmers with MSP of Rs 1.6 lakh crore, the food ministry said on Friday. The Food Corporation of India (FCI) along with state agencies undertakes procurement of paddy under price support scheme. The Centre has set a target to buy 62.60 million tonnes of rice in the 2022-23 marketing season (October-September).



submitted a status report to the Union Commerce Ministry highlighting the issues faced by them and also sought assistance from the government to achieve scale in their operations by setting up clusters. 




avos, India is more conscious of going for green energy than any other country in the world, Union Petroleum and Natural Gas Minister Hardeep Singh Puri said on Monday. He said special emphasis is being given on green hydrogen, biofuel blending and exploration and production of biofuel from alternative sources.



he government has approved 20 R&D projects worth Rs 61.09 crore across Geotech, Protech, Indutech, Sustainable Textiles, Sportech, Buildtech segments and Specialty Fibres (Carbon Fibre and Ultra High Molecular Weight Poly Ethylene), textiles ministry said on Thursday. The projects were approved at the 6th Mission Steering Group (MSG) meeting of the National Technical Textiles Mission chaired by textiles minister Piyush Goyal.



Production Linked Incentive Scheme 2.0 for steel as it aims at doubling the country's production capacity for the metal to 300 million tonne by 2030, an official said. Refractories are a critical input for steel production, and India depends on the import of the raw material. The Ministry of Steel is currently in talks with the refractory industry to develop an incentive policy to boost domestic production and reduce the country's dependence on imports from China, he said.

This means that all US dollar-denominated Nifty derivatives contracts will be exclusively traded on NSE IFSC. The migration of SGX Nifty derivatives to the NSE IFSC is a huge step forward for India. It will aid in attracting foreign investment into India, as well as improving the efficiency of the Indian financial system and making it more accessible to businesses and individuals. The article aims to highlight various benefits of this transition in detail.

The following are some of the advantages that the transfer of SGX Nifty derivatives to the NSE IFSC will bring to India:

- Rise in foreign investment: Foreign investment is likely to flow into India as a result of the transformation. This investment will aid in the growth of the Indian economy and the creation of new jobs.

SGX Nifty is a derivative of the Nifty 50 index, which is a market capitalization-weighted, free-float index of the top 50 companies listed on the National Stock Exchange of India. - More trading hours: The NSE GIFT exchange will offer extended trading hours for Nifty futures than the SGX. This will provide investors with greater trading and risk management flexibility.
- Direct access to Indian markets: On the NSE GIFT exchange, traders of Nifty futures will have direct access to Indian markets. This will enable them to trade Indian equities and other securities, providing diversification benefits.

The GIFT Nifty transaction is anticipated to have numerous advantages for investors. These advantages include reduced latency, increased competition, tax advantages, extended trading hours, and direct access to Indian markets.




